Federal Rule of Civil Procedure 30(b)(6), along with corresponding state rules, provides a tremendous but sometimes overlooked discovery tool for defense attorneys needing to efficiently gather a corporation's systems, policies, and practices. Attorneys Fouts and Kaplan will present a general overview of the rule, as well as the subtle differences between deposing or defending a corporate entity in Maine, New Hampshire, and Vermont. Topics will also include why an attorney may want to depose a corporate designee in a variety of matters, the distinctions between a 30(b)(6) deposition and a deposition of an individual witness, and factors to consider when deciding whether and how to proceed with a 30(b)(6) deposition.

Ethical Challenges of the High Profile Case

James Cooney practices civil and criminal law in both trial and appellate courts. He has handled some of the most complex, challenging and high profile cases in North Carolina and is recognized as one of the premier civil, "white collar" criminal, and healthcare litigators. He has represented numerous companies and individuals in complex and significant business disputes, governmental investigations, grand jury matters, internal investigations and "bet-your-company" cases for more than 30 years. He has tried more than 60 civil and criminal cases to verdict and argued nearly 50 appeals in the appellate courts of North Carolina and in the federal courts of appeal, including the Second and Fourth Circuits.

Jim is a fellow in the American College of Trial Lawyers and a Permanent Member of the Fourth Circuit Judicial Conference. He was selected for inclusion in The Best Lawyers in America in the fields of "Bet-the-Company" Litigation, Commercial Litigation, and Criminal Defense White Collar Litigation. In 2004 he received the N.C. Bar Association's William Thorp Pro Bono Award and in 2010 the Wade Smith Professionalism Award for Criminal Defense. In addition to his practice, he is the Chairman of the Litigation Department where he oversees more than 300 timekeepers.

He received his J.D. from the University of Virginia School of Law and his B.A. from Duke University.

- Counsel for Duke Energy in connection with a multi-district grand jury investigation and civil litigation arising out of the Dan River coal ash spill.
- Counsel for Duke Energy in connection with simultaneous investigations by the North Carolina Utilities Commission and North Carolina Department of Justice into the change in the Chief Executive Officer following the merger of Duke Energy and Progress Energy.
- Counsel for the Carolinas HealthCare System in federal and state antitrust litigation brought by the U.S. Department of Justice, the North Carolina Department of Justice, and individuals.
- Acting as counsel pro bono, freed a convicted death row inmate, Alan Gell, by exposing suppressed evidence that led to his wrongful conviction and sentence of death. Gell was the 113th person exonerated in the United States after being tried, convicted and sentenced to death. In the course of Gell's retrial, he presented first of its kind expert evidence in the forensic specialties of body decomposition/anthropology, reverse interior environmental engineering and entomology.
- Acting as counsel pro bono with the New York-based Innocence Project, freed Darryl Howard based upon DNA and forensic evidence. Howard was wrongfully convicted of double homicide and served more than 20 years in prison before he was released.



Matthew Cairns Matt Cairns is an Associate General Counsel for Textron Inc. where he manages national and international products liability litigation for its Specialized Vehicles product lines including E-Z-GO, Arctic Cat, Cushman and Tug. Prior to joining Textron, Matt was a proud member of the TDLA for 30 years while he practiced law in New Hampshire. He is a past New Hampshire State Rep for DRI, a former Northeast Regional Director for DRI, and served as the DRI President in 2011. Matt now lives in Rhode Island with his wife Tracey where it takes him 20 minutes to cut his lawn and he rides public transportation to work, in stark contrast to his life in New Hampshire. 
